The undersigned hereby acknowledges that they are required to connect the building foundation drain to the District's underdrain main system and permission to do so is subject to the following conditions:

1. This application is subject to the Grant W&S District's rules and regulations, including all present and future revisions thereto. Applicant hereby acknowledges that they have read the District's rules and regulations and shall abide by its requirements. Plans or sketches showing the building foundation drain and its underdrain service line layout and elevations must be submitted with this application for review and approval by the District's engineer.
2. This application is for a separate and independent underdrain service line tap for the above address only. The underdrain service line shall be installed and constructed as provided in the District's rules and regulations.
3. All underdrain service connections, appurtenances, and service lines extending there from are the property of the owner and/or user and must be maintained at the owner's/user's expense.
4. All underdrain taps must be inspected and approved by the District's Engineer. Applicant agrees to give the District Engineer two working days' notice for inspection of the tap connection to the District's underdrain main or stub-in pipe connection thereto. Failure to provide such notice and to receive the District's written approval of said connection shall be cause for re-excavation and inspection at applicant's expense.
5. Applicant agrees that NO unpolluted waters such as stormwater, surface water, roof runoff, unpolluted industrial process waters or uncontaminated cooling water and NO pollutant or domestic or industrial wastewater of any kind shall be discharged or caused to be discharged to the underdrain system of the Grant Water and Sanitation District.
6. This application is subject to payment of the District's underdrain tap permit application fee and underdrain inspection fee in affect as of the date of this application.
7. Applicant must install foundation drain and underdrain service line as shown on the approved plan or sketches attached to this application. The foundation drain and underdrain service line are required to flow by gravity to the District's underdrain main system.
8. Re-inspection will be required if installation is not complete or not installed in accordance with the approved plans. Payment of an additional inspection fee must be delivered to the District prior to scheduling the re-inspection.
9. Applicant must provide a person to verify for the District's inspector that the "as built" conditions match the approved design submitted with the tap application.
